Discussed the lease on the Huff Run Bldg. A large contingent from Mineral City Area Historical Society and Huff Run was in attendance. Huff Run/Rural Action has occupied the old town hall for over 20 year. Their lease expires Dec. 31, 2021 and the historical society would like use of the building which is the oldest in the village. Councilmember Brian Polen spoke and expressed that the council prematurely voted to terminate the lease with Huff Run. Council members Polen and Pirolozzi both expressed that council had not received all information needed in making a decision at the Nov. 11th regular meeting to terminate the lease. Rural Action submitted the monthly costs for utilities and council inquired with the historical society whether their organization would be able to maintain the expenses if leasing the building. The historical society indicated that they are financially stable and are able to maintain the utilities for the building. The historical society organization indicated that they would like to take possession of the building as soon as possible; as applying for grant funding is essential in having a lease for the building.

Visitors from Rural Action proposed that the village give Rural Action a one year extension on the lease. During that time they would find a new location and vacate the old town hall.

After discussion with solicitor Anderson and all parties involved, the council agreed to draw up two leases for the Huff Run Bldg.

*Motion made by Brian Polen and seconded by Angelo Pirolozzi to issue a lease to Huff Run/Rural Action on a month-to-month basis which will expire on June 30, 2022 and issue a lease to the historical society beginning on July 1, 2022.
